Section 10

Commencing December 17, 2017, and continuing on the 17th day of each month to and including November 17, 2019, the Borrower will make interest only payments on the Bond.

Commencing December 17, 2019 and continuing on the 17th day of each month thereafter, the principal and interest on the Bond shall be paid in equal monthly installments, with each monthly installment being based on a 20 year mortgage style amortization of the total outstanding amount of the Bond as of December 17, 2019, assuming an amortization period beginning on the December 17, 2019 and assuming a rate equal to the interest on the Bond.
